This is in reference to your letter No. D/56/DC II/EDMC/SHN dated 20/08/2018 on Sir. the subject cited above. In this connection, it is to inform you that the officer concerned of this department has carried out the inspection of the above mentioned school from fire safety point of view in presence of Mrs. Poonam Roy, Principal of the School to verify the compliance of shortcomings already communicated by this department vide letter No. F6/DFS/MS/School/2015/2264 dated 06/10/15 and was observed that following shortcomings have not been complied.

- 1. A fire pump having 220 LPM provided in place of 450 LPM output at 40 meters head as required.
- 2. Exit Signage not provided.

In view of above, the building can not be considered for issue of Fire Safety Certificate at this stage. Therefore you are suggested to rectify the above mentioned shortcomings under the intimation to this department for further course of action.
