1. Sanctioned/Completion plans in a scale of (1:100) with covered area and height of building.
2. Year of construction of school building.
3. Since how long the school is functioning in this building.
4. Detail of class room & no of students in class room.

In view of above, issuance of Fire Safety Certificate cannot be considered at this stage. You are requested to submit required documents/information for further action in this matter.
