Now the school management constructed new block ground plus one upper floor in 2018. In this connection, it is to inform you that to adjudge the applicability of fire prevention & fire safety measures, the following documents/information are required to be provided.

- 1. Sanctioned/Completion plans in a scale of (1:100) with covered area and height of building.
- 2. Year of construction of school building.
- 3. Since how long the school is functioning in this building.
- 4. Detail of class room & no of students in class room.

In view of above, issuance of Fire Safety Certificate cannot be considered at this stage. You are requested to submit required documents/information for further action in this matter.
