In this connection, it is to inform you that the officer concerned of this department has carried out the inspection of the above mentioned School from fire safety point of view in presence of Mr. Dharmendra (Incharge) of the School. During the course of inspection it was observed that the following points / shortcomings were noticed in the building comprised of ground plus three upper floors.

1. The Width of the staircase 1.50 meters wide are not provided
