Sub: - Regarding issuance of fire safety certificate in r/o M.C. Pry. Co.-ed School, Dhakka Delhi-09.
Sir.

Please refer to your letter no. nil dated 19.03.2017 on the subject cited above. In this connection this is to inform you that the above mentioned site was visited by the officer concerned of this department to verify the fire safety measures issued vide Director of Education circular dated 01.03.2011/ NBC Part 4 and observed that the school premise is comprised of newly constructed single block of having ground and two upper floor. At the time of inspection Smt. Santosh , S.K. was also present at site. During the course of inspection observations/ shortcomings made are as under:-

- 1. The gate width of 3.50m against requirement of 4.50m wide.
- 2. Hose reel hose not provided.
- 3. Pump capacity of 450 LPM with 40 mtr head not provided.
- 4. Overhead tank capacity of 10,000 ltr not provided.
- 5. Exit signage not provided at strategic locations in the building.

Keeping in view of above, fire safety certificate cannot be considered at this stage
