Please refer to your online application no. 2022041206793 dated 12/04/2022 on the subject mentioned above. In this connection it is to inform you that the premises was inspected by the officers concerned of this department on 23/04/2022 in the presence of Sh. Ashwani (Manager) to check the Shortcomings already issued by this deptt. Vide Letter No.F6/DFS/MS/WZ/2020/49 dated 09/01/2020, F6/DFS/MS/WZ/2020/317 dated 19.03.2020,F6/DFS/MS/MN/2021/242 dated 24/05/2021.

During course of inspection, it was observed that the restaurant is running at Third Floor in a Building comprised of Basement, Stilt, Ground plus three upper floors only. However, the statuses of shortcomings are as under.

6.	Main & stand by pumps of 2280 lpm are not provided.	Not Rectified
7.	Terrace Fire Pump of 450 lpm with 40m head is not provided.	Provided but not working
8.	Under Ground Fire Water Tank of 100000 ltrs is not provided	Not Rectified
9.	Overhead water tank of 10,000 ltrs capacity not provided.	Rectified
10.	Jockey pump of 180 LPM found not provided.	Provided but not working
11.	Exit signage's not provided.	Not Rectified

In addition to the above, the use of terrace floor as restaurant shall not be run without the permission of concerned local authority.

In view of above shortcomings, issuance of fire safety certificate is rejected. You are requested to submit point wise compliance & till such time occupancy of the building/premises in absence of requisite fire safety arrangements shall be at the risk and liability of the owner/occupier. The licensing Authority/Statutory Authority may take suitable necessary action as deemed fit.
