Please refer to your Online Application ID. No. 2022042107786 dated 21/04/2022 on the subject cited above. In this connection, it is to inform you that the said premise was inspected by the officer concerned of this department on 13/05/2022 in the presence of Sh. Aman to check the Fire safety arrangements.

During inspection, It was observed that the building is comprised of Basement + Ground + 03 Upper Floors, Guest House is running at Ground floor (Reception) + 1st Floor (06 rooms) + 2nd floor (06 rooms) & 3rd floor (06 rooms). Fire safety arrangements such as Smoke Management System, Fire Extinguishers, First-Aid Hose Reel, MOEFA, Internal Hydrant, Pumping Arrangement, Overhead Tank, and Exit Signage etc. However, following shortcomings were observed:-

- 1. Fire Check Door Found removed in Basement.
- 2. First Aid Hose reels are provided but not working.
- 3. Carbon Monoxide (CO) detector is not provided.
- 4. Location of Main Panel at Ground Floor is not provided.
- 5. Hooters Location at all floors are not provided.
- 6. MOEFA is provided but not working.
- 7. Automatic sprinkler system is provided in Basement but not Functional.
- 8. Terrace pump of 450 LPM & 180 LPM is provided but not functional & not on auto mode.
- 9. Overhead water storage tank 2000 ltr provided against requirement of 5000ltr.
- 10. Exit signage's are found removed.

In view of above shortcomings, the application for Renewal Fire Safety Certificate is rejected. The occupancy of the building/premises in absence of requisite fire safety arrangements shall be at the risk and liability of the owner/occupier. The licensing Authority/Statutory Authority may take suitable necessary action as deemed fit.
