The premise was inspected by the concern nominated authority of this department in presence of Sh. Deepak Mehra (Owner) on 05/11/2019 to ascertain the availability and operability of fire protection and fire safety measures. During inspection, following poits were observed:

- 1. Width of Exit doors is not meeting the requirement.
- 2. The First-Aid Hose Reel is not provided.
- 3. The MOEFA system is not provided.
- 4. The Internal Hydrant is not provided.
- 5. The Overhead water storage & terrace pump in conformity with Table-7, NBC-IV, of 2016 is not provided.
- 6. The required illuminated exit signage not provided.

Keeping in view of above, the Fire Safety Certificate cannot be issued at this stage in the interest of public safety.
