

In this connection, it is to inform you that the above mentioned premise was visited by the officer concerned of this department and observed that the shortcoming intimated vide letter of even no. 635 dated 20/09/2021 has yet not been complied. In view of above Shortcomings, the application for issuance Fire Safety Certificate is rejected. The occupancy of the building/premises in absence of requisite fire safety arrangements shall be at the risk and liability of the owner/occupier. Sir,

This is in reference with MHA Portal ID 2021072515833 dated 29/07/2021 on the subject cited above. In this connection, the premises have been inspected by officer concerned of this department on 31.08.2021 in the presence of Mr. Santosh Jha, (Manager) of the Guest House. During the inspection, it was observed that the Guest House is running Basement, Ground + Three Upper Floors. The shortcomings observed are as below:

1. The building is not accessible to fire engine.
2. Width of corridor is 1.15 mtr against the required width of 1.50 mtr.
3. Smoke management system not provided in the basement and upper floor.
4. Manual Operation Fire Alarm System not provided.
5. Automatic Sprinkler System provided but not working.
6. Exit Signage not provided.
7. The building is divided into two blocks interconnected with 1 mtr wide bridge passage through ventilation shaft.

In view of above Shortcomings, the application for issuance Fire Safety Certificate is rejected. The occupancy of the building/premises in absence of requisite fire safety arrangements shall be at the risk and liability of the owner/occupier. The Licensing authority/ Statutory Authority may take suitable necessary action as deemed fit.
