1. Alternate exit of 1.5 meter is not provided.
2. First aid hose reel and hydrant systems are not provided.
3. MOEFA is not provided.
4. Terrace pump of 450 LPM is not provided.
5. Overhead fire water tank of capacity 20000 Ltr is not provided.
6. Exit signages found inadequate.
7. There shall be no entry from guest house to the restaurant.

In view of above, Fire Safety Certificate cannot be issued. Therefore, you are requested to rectify the shortcomings for further consideration in the matter.
