from Fire Safety and means of escape point of view.**

Sir,

Please refer to your letter No. 23(16)/AE(E)-III/41/244 dated 25/11/2020 on the subject noted above, in this connection, it is to inform you that the said premises was visited by the officers concerned of this department on 04/12/2020 in the presence of Mr. Virender Singh, AE(E) & Subhash Meena, J.E. (E) and observed that the building comprised of Common two tier basements Ground plus four upper floors (one block, ground plus five upper floors (Two Blocks) & ground plus six upper floors (Two Block) All Blocks are interconnected.

However following shortcomings were observed during the time of inspection:-

- ✗ 1. Mechanical Ventilation is provided in basement but found nonfunctional.
- ✓ 2. All blocks are interconnected but found locked / Blocked at each floor v.i.z. access to other blocks of the building are blocked by locking.
- ✗ 3. Fire Extinguishers provided but nonfunctional.
4. Automatic fire detection and alarming system were provided but found nonfunctional at some places.
- ✗ 5. Exit Signage & Lift Signage found removed at some places.
- ✓ 6. Pressurization at lift lobby & lift shaft were provided but found nonfunctional.

In view of above NOC/ FSC is rejected under Rule 37 (3) of DFS Act 2007, Rules 2010.

You are requested to rectify above mentioned shortcoming under intimation to this department for further necessary action please.
