

Sub: - Regarding issuance of Fire Safety Certificate in r/o Convent of St. Garjiya, Vani Vihar, Uttam Nagar, New Delhi-110059.

Sir,

This has reference to your Letter No. COSG/Misc/f86/2019 dated 27.03.2019 on the subject cited above. In this connection, it is to inform you that the inspection of above said school building has been carried out by officer concerned of this department on 26.04.2019 to see the requisite fire safety measures. Smt. Ritu (Coordinator) was present at the time of inspection.

During the course of inspection it was observed that school building comprised of ground plus two upper floors. The upper floors are served by two staircases having width 106 & 94 cms. The electrical wiring was seen concealed and the electric supply was passing through MCB's. The following shortcoming was observed:-

1. The building is not approachable through 06 meters wide road.
 2. The upper floors are served by two staircases having width 106 & 94 cms against required two staircases having width not less than 150 & 100 cms each.
 3. Door width is 87 cms against required 120 cms.
 4. Hose reel system is not provided.
 5. Fire pump having capacity 450 LPM not provided for hose reel system.
 6. Overhead water storage tank of 10,000 ltrs capacity not provided for hose reel system.
 7. Exit signs are not provided.
- If student capacity is more than 45 in any class room then double door having width 120 cms is required.

You are advised to rectify the above-mentioned shortcomings for taking further action as necessary for grant of Fire Safety Certificate.
