It is advised that occupancy should not be allowed till fire safety arrangements are provided in the restaurant.

**Sub:** -Regarding issue of "Fire Safety Certificate" from fire safety point of view in r/o M/s Dilli 59 ( A Unit of Aggarwal Traders) WZ-154,G-1, block, Najafgarh Road near metro pillar 680, Uttam Nagar, New Delhi.

Sir,

Please refer to your letter ID No. 2021041212818 dated 14/04/21 on the subject cited above. In this connection this is to inform you that officer concerned of this department inspected the building to verify the fire safety arrangements in accordance with the rules. At the time of inspection Sh. Rajesh Sharma was present and it was observed that the building is comprised of Basement, stilt, upper ground, first & second floor but restaurant is running at upper ground & first floor and have following shortcomings:-

- An additional staircase shall be provided 1.5 m wide.
- 2. One of the exit shall be 2 m wide instead of 1.7 m in restaurant.
- 3. Fire check door not provided.
  - 4. First aid hose reel & down comer system provided but not functional.
  - 5. Fire pump having 450 LPM provided but not functional & auto mode.
- ∠ 6. Over head water tank 15, 000 liters provided in place of 20,000 liters.
  - Exits signage's are not provided.

In view of above shortcomings, the application for issuance Fire Safety Certificate is rejected. The occupancy of the building/premises in absence of requisite fire safety arrangements shall be at the risk & liability of the owner/occupier. The Licensing Authority/Statutory Authority may be take suitable necessary action as deemed fit.
