Sub:- Regarding Issuance Fire Safety Certificate r/o M/s EDMC Primary School located at Old Seemapuri (Urdu), Delhi-110095. Sir.

This is in reference to your letter No. nil dated 15/10/2018 on the subject cited above. In this connection, it is to inform you that the officer concerned of this department has carried out the inspection of the above mentioned School from fire safety point of view in presence of Mr. Mohd Arif, In-charge of the School. The following points / shortcomings were noticed in the building comprised of ground plus two upper floors.

- 1. A fire pump having 220 LPM provided in place of 450 LPM output at 40 meters head as required.
- 2. Exit Signage were not provided.

In view of above, the building cannot be considered for grant of Fire Safety Certificate at this stage. Therefore you are suggested to rectify the above mentioned shortcomings under the intimation to this department for further course of action.
