With reference to your letter on the subject cited above, it is informed that officer concerned of this department inspected the school from fire safety point of view in presence of Ms. Savita Arora, Principal of the School on dated 19/10/2019. The School building comprises of ground plus first floor. During the course of inspection following observation was made:-

1. The school is not accessible to fire engines as road width is less than 6 meters.

In view of the above, the school building cannot be considered for issuance of Fire Safety Certificate at this stage. Therefore, you are requested to provide the above mentioned fire safety arrangements under intimation to this office for further course of action.
