Please refer to your online application no. 2022061713034 dated: - 17/06/2022 on the subject mentioned above. In this connection, it is to inform you that the premise was inspected by the officer of this department on 29/06/2022 in the presence of Sh. Shubham (Care Taker) to check the fire safety arrangements.

During inspection, It was observed that the said guest house is running at, 2nd & 3rd floor in a building comprised of Basement, Ground Plus three upper floors (bank is running at basement, ground & 1st floor). Fire safety arrangements such as Fire Extinguishers, Exit Signage, Overhead Water Tank, Terrace Pump, Smoke Management System, Internal Hydrant, MOEFA etc. found provided. However, following shortcomings were observed:-

- 1. Fire check door found removed at some places.
- 2. First Aid-Hose Reels are provided but not functional.
- 3. MOEFA is provided but not functional.
- 4. P.A System is provided but not functional.
- 5. Overhead Water Storage tank capacity of 5000 ltr is provided but uses as domestic purpose.
- 6. Exit signage is found removed at some places.
- 7. Smoke Management system is not provided in upper floor.
- 8. Building plan uploaded on MHA Portal is not signed by registered architect & owner/occupier of the guest house.

In view of above shortcomings, the application for renewal of Fire Safety Certificate is not considered at this stage & rejected. The occupancy of the building/premises in absence of requisites fire safety measures shall be at the risk and liabilities of the owner/occupier. The licensing issuing authority /statutory authority may take suitable necessary action as deemed fit.
