
During inspection it has been observed that the said building is comprised of ground plus two upper floors. Fire safety arrangements such as overhead water storage tank, fire pumps capacity 900 & 180 LPM, hose reels, down comer, fire extinguishers etc. found provided. However, following shortcomings were observed: -

1. Domestic connection in overhead water storage tank shall be removed.
2. Fire pumps were not in auto mode.
3. Exit signages are not provided.

In view of the above shortcomings, fire safety certificate cannot be renewed at this stage. You are requested to rectify the above mentioned shortcomings and submit point wise compliance for further necessary action in this matter.


