The licensing issuing authority/statutory authority is requested that premises should not be allowed to run till it provide all necessary fire arrangements.


Please refer to your online application no. 2021090319986 dated 03/09/2021 on the subject mentioned above. In this connection, it is to inform you that the premise was inspected by the officers of this department on 28/09/2021 to check the fire safety arrangements.

During inspection, It was observed that the building is comprised of Basement, Ground plus 03 Upper Floors served by single staircase having width 0.9 mt., Guest House is running Ground Floor, first Floor, Second Floor & Third Floor. Fire safety arrangements such as Fire Extinguishers, Exit Signage etc. found provided. However, following shortcomings were observed:-

1. One Staircase of width 90 cm provided against requirement of two staircases having width 1.5m each.
2. Width of corridor 93 cm provided against 1.5 m required.
3. Width of the doors is 01 mts provided against 1.5 mts required.
4. Smoke management system is not provided in the basement & upper floor.
5. Carbon Monoxide detectors are not provided.


In view of above shortcomings, the application for issuance of Fire Safety Certificate is not considered at this stage & rejected. The occupancy of the building/premises in absence of requisites fire safety measures shall be at the risk and liabilities of the owner/occupier.
