J.S Chauhan (Asstt. Director, Estate) and Sh. S.K Tanwar (A.E. Electrical). Your request for issuance of FSC is rejected as following shortcoming/observations were observed at the time of inspection.

Academic Block:

- 1. First aid hose reel provided but not functional.
- 2. Exit signage found missing at some strategic locations.

Seminar Block:

- 1. Smoke management system not provided in auditorium hall.
- 2. Beam detectors are not installed at suitable locations.
- 3. Seating arrangement is not as per DSA/NBC as there are more than 14 seats are in a row.
- 4. Fist aid hose reel not provided near auditorium hall.
- 5. Exit signage not provided.


You are requested to apply again after compliance of the above mentioned shortcomings for further consideration in this matter.
