This is in reference to your letter no. Nil dated 2.9.2019 on the subject cited above. In this connection, it is to inform you that above said school building have been inspected by the officer concerned of this department on 16.10.2019 in presence of Sh. Sanjeev Rathee (Headmaster) to see the fire safety arrangements provided there in.

During the course of inspection it has been observed that the School building consist of two blocks namely Block No.1 & 2, comprised of ground plus three upper floors. The following shortcomings have been observed:-

1. 8 Nos. ABC Fire extinguishers are provided but not refilled/updated.
2. First Hose Reel is provided at each floor but found non functional.
4. Fire pump capacity 450 LPM at terrace level provided, but found non functional.

In view of the above shortcomings fire safety certificate cannot be renewed at this stage. You are thus advised to rectify the shortcomings under intimation to this department for consideration of Fire safety Certificate.
