Sir.

This has a reference to the online application ID-2022040705893 dated 08.04.2022. The matter was examined and observed that earlier this department had issued FSC to the aforesaid premises for ground floor only vide letter No. F.6/DFS/MS/BNQT/2019/SZ/1934 dated 10.10.2019, whereas, the recent proposal, as submitted by you through MHA Portal is for banquet at Ground, mezzanine and first floor. But, the building plans, as submitted by you, are not appropriate for the purpose of scrutiny from fire safety point of view.

Therefore, you are requested to submit an appropriate set of sanctioned/approved building plans of said Building i.e. site/layout plans, all floor plans, section, elevation and terrace plan, duly marked with fire safety arrangement as stipulated in UBBL-2016/NBC-IV, 2016 on 1:100 scale. If sanctioned/approved plans are not available, submit building plans through building sanctioning/licensing authority for further consideration in the matter.
