
Sir,
This is in reference with your letter No. SVPS-19 dated 03.10.2019 received in outdoor diary no. 23809 dated 31.10.2019, on the subject cited above. The premise was inspected by the concerned authority of this department in presence of Smt. Ritu Ghai (Principal) on 13.01.2020 to verify the compliance of fire prevention and fire safety measures required under the rules. The renewal of FSC is rejected under sub rule (3) of Rule 37, in the view of reasons mentioned below:

1. The school running at first floor is not segregated from factory running at ground floor.

In this regard as stipulated in sub Rule (1) of Rule 37 of DFS Act-2007 & Rules 2010 you are advised to apply again in Form "J" along with a certificate from Architect/ owner that all the fire prevention and fire safety measures are provided as per Rule 33 of DFS Act-2007/ Rules 2010 in the building/premise & duly filled Performa enclose herewith.
