In view of above Shortcomings, the application for issuance Fire Safety Certificate is rejected. The occupancy of the building/premises in absence of requisite fire safety arrangements shall be at the risk and liability of the owner/occupier.

Sub .:- Renewal of Fire Safety Certificate.

Sir,

This has reference to your letter No. Nil dated 24/07/2019 on the subject cited above. In this connection the school premises was inspected by the officer concerned of this department on 12/09/2019 in the presence of Mrs. Usha Agarwal Sandeep (Principal). During the course of inspection it was observed that school building is comprised of ground plus three upper floors (school running at ground and first floor).

The shortcomings observed are as below: -

- 1. One staircase required with the width of 0.75m found removed.
- 2. First aid hose reel provided but found non-functional.
- 3. Terrace level pump capacity 225 LPM with 25m head found non-functional and not provided on auto mode.
- 4. Overhead water tank of 2,500 liters capacity for firefighting is not provided at terrace.
- 5. Exit signage not provided at conspicuous places at every floor.

In view of above shortcomings, Fire Safety Certificate cannot be considered at this stage. You are requested to rectify the shortcoming under intimation to this department for further action in the matter.
