



Sir,

Please refer to your letter no. Nil dated 2/05/2015 on the subject noted above, it is informed that the said school building premises have been inspected by the officer concerned of this department on 30/05/2015.

During course of inspection the following shortcomings were observed.

1. Width of class room's doors varies from 92cm to 100 cm against required minimum 100 cm clear width.
2. Terrace pump of 450 lpm not provided.
3. Over Head water tank of 10000 ltrs not provided.
4. Exit sign not provided.
5. LPG cylinder are being used without precutation it should be as per DOE circular dated 1/03/2011
6. Electric wiring should be in metal conduit/concealed type.
7. Electric meter has been installed under stairs require to be taken to a safe place away from stairs.

You are requested to comply above shortcomings with in 90 days inder intimation to this department otherwise action will be taken as per Delhi Fire Service act2007 and rule 2010.The premises shall be at your risk & cost.
