
In view of above, the application for renewal of Fire Safety Certificate can't be considered at this stage. The school management is requested to apply only for permanent structure school building.

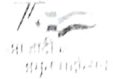


