Sir,

This has reference to your Letter No. Form 'J' dated 05.04.2018 on the subject cited above. In this connection, it is to inform you that the inspection of above said school building has been carried out by officer concerned of this department on 08.05.2018 to see the compliance of the requisite fire safety measures. Sh. D.V.S Shastri (Manager) was present at the time of inspection.

During the course of inspection it was observed that school building comprised of ground floor plus two upper floors having total ten rooms on GF, ten rooms on FF, ten rooms on SF was issued NOC by this department vide letter no. F.6/DFS/MS/2008/1029 dated 10.04.08. Now new rooms have been constructed on each floor level and having total 42 rooms (14 rooms on each floor). The upper floors are served by four staircases having width 130 cms each. The existing fire protection arrangement such as fire extinguishers, fire pumps, exit signs etc. are provided in the building. The school building is approachable to the fire fighting vehicles. The electrical wiring was seen concealed and the electric supply was passing through MCB's. The following shortcomings were observed:-

- 1. Door size of newly added class rooms on each floor level is 90 cms against required 120 cms.
- 2. Additional First aid hose reels are required on each floor.
- 3. Overhead water storage tank of 5000 ltrs. capacity is provided against required 10,000 ltrs capacity.

You are advised to rectify the above-mentioned shortcomings for taking further action as necessary for grant of Fire Safety Certificate.
