## Sir/Madam,

This is in reference with your letter No. 422/19/MDM dated 09.12.2019, received in outdoor diary no. 27843 dated 18.12.2019 subject cited above. The premise was inspected by the concern nominated authority of this department in presence of Sh. Mukesh (Teacher) on 07.03.2020 to verify the compliance of fire prevention and fire safety measures required as per FSC issued vide this office letter No. 24 dated 06.01.2017. The renewal of FSC is rejected under sub rule (3) of Rule 37, as there was alteration in building by adding one more floor on existing building.

In this regards as stipulated in sub Rule (1) of Rule 37 of DFS Act-2007 & Rules 2010 you are advised to apply again in Form "J" along with a declaration from owner/occupier on Form "K" as required under Rule 38 that all the fire prevention and fire safety measures provided in the building/premise are in best repairs. The web links for DFS Act-2007/ Rules 2010 & Form "J" & "K" are as under: You are in best repairs after restoration of existing building in conformity with the approved sanctioned plans/ previous FSC.

## OR

You may first apply with concerned building sanctioning authority under clause 2.3 of UBBL-2016 under Addition/ Alteration for approval of existing building, afterward you may apply for issue of OCC under clause 2.6 of UBBL-2016 and this department will communicate the status of FSC or its rejection under Rule 35 of DFS Rule-2010, to the building authority and the owner/applicant within the stipulated time after the inspection of building/premises as mandate in clause 2.7.7 of UBBL-2016.
