This has reference to your letter no. Nil dated 01.02.2019 on the subject cited above. In this regard it is to inform you that school building was inspected by the officer concerned of this department on 04.04.2019 to see the requisite fire safety measures. Sh. Rajesh Gupta (Chairman) was present at the time of inspection

During the course of inspection it was observed that the premises comprised of Ground floor plus four upper floors and height seems to be more than 15 meters. Hence you are advised to submit two sets of sanctioned building plans/regularised building plans with section/elevation of the building on the scale of 1:100 duly marked with fire and life safety system or building plans must be forwarded by building authority for further necessary action w.r.t. issuance of fire safety certificate.
