- 1. Trimming of trees must be done to ensure free movement of fire vehicles around the
- 2. Staircases must be kept free from any obstruction & must not be locked at terrace.
- 3. Two fire extinguishers of ABC type 4 kg capacity must be provided and maintained at each floor in all blocks.
- 4. Hose Reels & Hydrants sy stem found nonfunctional.
- 5. Two hoses with branch must be provided at each floor.
- 6. Manual call point found nonfunctional.
- 7. Terrace Pumps found nonfunctional.
- 8. Communication system in the lift found nonfunctional.

You are requested to comply the abovementioned shortcomings under intimation to this department.

The FSC issued vide letter no F6/DFS/MS/CGHS/2017/SZ/936 dated 29/06/2017 shall be remain suspended till the compliance of above shortcoming.

. In view of the above shortcomings Fire Safety Certificate cannot be considered at this stage.
