
Madam,

Please refer to your letter RSKV/698 Dated 05/12/18 on the subject cited above. In this connection this is to inform you that officer concerned of this department inspected the school to verify the fire safety arrangements in accordance with the Circular no. F.16/Estate/CC/FS/2011/3298 to 3398 dated-1.3.11. At the time of inspection Mrs. Manju Khati (Principal) & Dilip Bist (Estate Manager) was present and it was observed that the school building is comprised of A & B block ground plus two upper and C & Primary blocks ground plus one upper floor and have following shortcomings:-

1. An additional staircase having width of 1.5 m shall be required in A, B & C block.
2. First Aid Hose reels not provided A & B block.
3. Fire pump having 450 LPM output at 40 m head not provided in A & B block at terrace.
4. Over head tank capacity of 10,000 liters not provided in A & B block.
5. Exit signage's not provided.

In view of above, the fire safety certificate cannot be considered at this stage. You are requested to rectify the above shortcoming under the intimation to this department for further course of action.
