Sir,

This is in reference to your letter received in outdoor diary no. 12080 dated 24/08/2018 of this department, on the subject cited above. In this regard it is to inform you that FSC under Rule 35 of DFS Rules-2010 is issued only for those premise which are referred by local authority as specified in section 2 (q) of DFS Act-2007 to this department and no such reference of the said premise is available in the records of this department.

In this context kindly note that since 2015 to till date the same has been continuously communicated to you by this department as referred above, you are once again requested to apply through building sanctioning authority as per law of land along with approved building plans of premise OR you may apply again in Form "I" and it shall be accompanied with a certificate from the architect and owner or occupier that all the fire prevention and fire safety measures as required under rule 33 have been incorporated in the building after sanction of existing building under clause 2.1 of UBBI-2017, for further consideration in this regard.
