Madam,

This is with reference to your letter No. LC/Fire Safety/2019/01 dated 25/03/2019 received in this department outdoor dairy No. 7116 dated 28/03/2019 on the subject cited above. In this connection, the school premise have been visited by the officer concerned of this department on 16/08/2019 in your presence to verify the availability & operability of fire prevention and fire safety measures required under the rules. During the inspection, it was observed that an additional building block comprised of stilt plus two upper floors having an auditorium at upper floor have been constructed. The shortcomings observed are as below.

Old Building Blocks: -

1. Interconnection of old blocks found blocked at 2nd floor by erecting bricks wall. Front block is served with single staircase of 1.36m, hence an additional staircase shall be provided.
2. Hose-reel hose provided found non-functional i.e. nozzles missing and the length of hose reel pipe found less than 30m.
3. Exit signage found removed from some locations as indicated during inspection.

New Building Block: -

1. Sanctioned/ Completion plan of the building or as built drawings of the building from a registered architect showing covered area / section / elevation on a scale of 1: 100 through building authority may be submitted to take necessary action.

In view of above, issuance of Fire Safety Certificate cannot be considered at this stage. You are requested to rectify the shortcoming under intimation to this department along with required document in r/o new building block for further action in the matter.
