During the inspection, it was observed that the Guest House is running in Ground + five upper floors with temporary structure at terrace & kitchen. Whereas, earlier FSC was issued by this department for building comprised of ground + four upper floors only. In this connection you are advised to refer two sets of building plans drawn on the scale of 1:100 duly marked with fire fighting arrangements as per National Building Code of India (Part -4)/UBBL-2016.

Hence, you may take necessary action accordingly for further consideration in the matter.
