In this connection it is to inform you that aforesaid establishment (Confectionary) in a building comprised of Basement + Ground + 03 Upper Floors & Covered Terrace, has been inspected by the officer concerned of this department on 18.10.2021 in the presence of Sh. Ashish Aggarwal (Manager) to check the Fire Safety Measures provided in the building.

During inspection, the following shortcomings have been observed:-

- 1. Basement floor is not compartmentalized/segregated providing Fire Check Door.
- 2. The Width of Exits is 166 cm & 90 cm instead requirements of 1.5 m each.
- 3. Smoke Management System is not provided.
- 4. Fire Extinguishers are not provided.
- 5. Down comer System along with First Aid Hose Reel with 30 m long pipe having 20 mm dia with Shut off nozzle & Hydrant with hose and hose box & Branch is not provided.
- 6. MOEFA is not provided.
- 7. Fire Pump at 450 lpm capacity at Terrace is not provided.
- 8. Over head tank 20,000 ltrs. capacity exclusive for firefighting is not provided.
- 9. Exit Signages are not provided.

In view of the above shortcoming, the application for issuance Fire Safety Certificate is rejected. The occupancy of the building/premises in absence of requisite fire safety arrangements shall be at the risk and liability of the owner/occupier.
