This is in reference to your letter no. nil Dated- 26/08/2020 on the subject cited above. In this connection, it is to inform you that the officer concerned of this department has carried out the inspection of the above-mentioned school from fire safety point of view in presence of Mrs. Priyanka Gulati (Principal). The school building is comprised of ground plus four upper floors. During the course of inspection, the following points / shortcomings were noticed: -

- 1. First Aid Hose reels provided but not functional.
- 2. Down-comer system provided but not functional.
- 3. Fire pump having 450 LPM provided but not functional.
- 4. The porta cabin constructed on the terrace floor should be removed.
- 5. Nursery school running in porta cabin that should be avoided.

In view of above, the fire safety certificate cannot be considered at this stage. You are requested to rectify the above shortcoming under the intimation to this department for further course of action.
