
**Sub:** Regarding issuance of Fire Safety Certificate (FSC) in r/o SDMC Primary Girls School,

In this connection, it is to inform you that the above mentioned premise was visited by the officer concerned of this department and observed that the shortcoming intimated vide letter of even no. 4588 dated 13/12/2012 has yet not been complied. In view of above Shortcomings, the application for issuance Fire Safety Certificate is rejected. The occupancy of the building/premises in absence of requisite fire safety arrangements shall be at the risk and liability of the owner/occupier. The Licensing authority/ Statutory Authority may take suitable necessary action as deemed fit.

Sir,


This has reference to your letter no. Nil dated. 28/09/2012 on the subject cited above. In this connection the inspection of the said premises was carried out by the officer concerned of this department on 29/11/2012 to verify the fire safety arrangements provided in accordance with Directorate of Education Circular No. F.16/Estate/CC/Fire Safety/2011/3298-3398 dated 01/03/2011. During the visit, it was observed that the school building is comprised of ground floor only.

During the course of inspection, the following short-comings were observed: -

1. Class rooms with more than 45 students have only one exit, where as there should be two exits in each such class rooms having width of 1.0 mtrs.
2. Only 02 fire extinguishers found provided, which are inadequate. 02 more fire extinguishers to be provided.

In view of the above shortcomings, grant of Fire Safety Certificate / N.O.C. from fire safety point of view to the said premises can not be considered at this stage. You are requested to rectify the above mentioned shortcomings under intimation to this department.
