
Please refer to online application no. 20220105181131 dated 05.01.2022 on the subject cited above. In this connection it is to inform you that aforesaid building/restaurant at Ground & First Floor have been inspected by the officer concerned of this department on 24.01.2022 in the presence of Sh. Rahul (Manager) to check the Fire Safety Measures provided in the building as per UBBL & NBC Part-IV.

During inspection, the following shortcomings have been observed:-

1. Width of staircases is 1.17 m to 1.40 m up to terrace & 1.10 m to 1.18 m Ground to 1st floor against requirement of 1.5 m each up to terrace.
2. Width of Exit Doors is 1m against requirement of 1.5 m each.
3. Kitchen is not compartmentalized from restaurant area provided fire check door.
4. Smoke Management System is not provided.
5. First Aid Hose reel along with 30 m long hose 20 mm dia. with shut off nozzle 5 mm dia. is not provided.
6. MOEFA is not provided.
7. Hydrant along with hose & hose branch with box is not provided.
8. Fire Pump 450 lpm at terrace is not provided.
9. 20,000 ltrs Capacity overhead water storage tank exclusive for firefighting is not provided.
10. Exit Signages are not provided.

In view of the above shortcoming, the application for issuance Fire Safety Certificate is rejected. The occupancy of the building/premises in absence of requisite fire safety arrangements shall be at the risk and liability of the owner/occupier. The Licensing Authority/statutory Authority may take suitable necessary action as deemed fit.
