

This is with reference to your letter No. Nil dated 15/05/2019 received in this department outdoor dairy No. 4357 dated 16/05/2019 on the subject cited above. In this connection, it is to inform you that school premise have been visited by officer concerned of this department on 31/07/2019 in your presence. The school building is comprised of ground plus three upper floors (G+3). Thus to adjudge the applicability of fire prevention & fire safety measures, the following documents/information are required to be provided.

1. Sanctioned / Completion plan of the building.
2. As build plan of the building on a scale of 1:100 showing section/elevation, if sanctioned/completion plan is not available along with documents supporting year of construction of the building.
3. Initial date of running of the school with supporting documents.

In view of above, issuance of Fire Safety Certificate cannot be considered at this stage. You are requested to submit required documents/information for further action in this matter.
