Sub: - Regarding issue of "Fire Safety Certificate" from fire safety point of view in r/o The Neev School B-7, Gurudwara Road, I.P. Extension, Patpargang, Delhi-92.

Please refer to your letter no. dated 02/12/19 on the subject cited above. In this connection this is to inform you that officer concerned of this department inspected the school to verify the fire safety arrangements in accordance with the NBC Part-IV. At the time of inspection Mrs. Anshu Goel (Principal) was present and it was observed that the school building is comprised of ground plus three upper floors and have following shortcomings.

- 1. The width of staircase is less than 1.5 m for both the staircases & should lead to /
- 2. First Aid Hose reels not provided.
- 3. Over head water storage tank 10,000 liters capacity not provided.
- 4. Fire pump having 450 LPM out put at 40 m head not provided.
- 5. Exits signage's are not provided.

In view of above, the fire safety certificate cannot be considered at this stage. You are requested to rectify the above shortcoming under the intimation to this department for further course of action.
