In this connection, it is to inform you that the premises was inspected by the officer concerned of this department on 11/03/2022 in the presence of Sh. Vinay Kumar (Manager) to check the fire safety arrangements provided in the building.

During inspection, it was observed that the said restaurant is running at 3<sup>rd</sup> floor in a building comprised of Basement+ Stilt+ Upper Ground plus 3 upper floors. However the following shortcomings were observed:

- 1. Width of Stair is 1 x 152 cm & 1 x 170 cm from staircase is blocked.
- 2. Width of door size is 1 x 113 cm & 1 x 153cm provided instead of 1.5 mtr each.
- 3. Main fire pump of 2280 lpm, Jockey pump 180 lpm, and stand by pump 2280 lpm are not provided.
- 4. Underground Water Storage tank of capacity 1, 00,000 ltrs is not provided.
- 5. Exit Signage's are not provided.

In view of above Shortcomings, the application for Issuance of Fire safety Certificate is rejected. The occupancy of the Building/ premises in absence of requisites fire safety Arrangements Shall be at the risk and liabilities of the Owner/occupier. The Licensing authority /statutorily authority may take suitable necessary action as deemed fit.
