This is in reference to Online application No. 20201212144231 dated 23.12.2020 on the subject cited above. The premise was inspected by the concern nominated authority of this department on 02.03.2021, in presence of Mr. Gulshan (Manager) to ascertain the availability and operability of the fire prevention and fire safety measures. The following shortcomings were observed:

- 1. Kitchen found running on terrace in tin sheds /Temporary structure.
- 2. 10,000 ltrs Over Head captive fire water tank provided against the required capacity of 15,000 ltrs.
- 3. Second staircase is not provided in the basement.
- 4. Smoke management/ ventilation is not provided the building & staircase width is less than 1.5m.
- 5. Fire check door not provided in the building.
- 6. Exit/ lift signage are not provided.
- 7. Fire detection system is not provided in basement.
- 8. No drawings are provided in CAF, accordingly plans may be provided.
- 9. Document proof for the year of construction may kindly be provided.

In this regard as stipulated in sub Rule (5) of Rule 35 of DFS Act-2007 & Rules 2010 you may apply with a fresh application for grant of fire safety certificate under sub-rule (2)on Form "(" and it shall be accompanied with a certificate from the architect and owner or occupier that all the fire prevention and fire safety measures are duly complying with the requirements as communicated under sub-rule (4) above, for further consideration in this regard.
