This is in reference to the online application received through MHA portal vide online ID No. 2023060910576 dated 09/06/2023 on the subject cited above. In this connection, it is to inform you that the premises was re inspected by officer concerned of this department on 16/06/2023 in the presence Sh. Dilip Kumar (Manager) to check the shortcomings already issued by this deptt. vide letter No.- F6/DFS/MS/WZ/EH/2022/176 dated 11/02/2022.

During inspection, it has been observed that said restaurant is running at Ground Floor in a building comprised of Ground + 02 Upper Floors. Fire safety arrangement of the restaurant such as Fire Extinguishers & Smoke Management System is provided. However, the status of shortcomings are as under.

In view of above Shortcomings the application for Issuance of Fire safety Certificate is rejected. The occupancy of the Building/ premises in absence of requisite fire safety arrangements shall be at the risk and liabilities of the Owner/occupier. The licensing issuing authority/statutory authority is requested that premises should not be allowed to run till it provide all necessary fire arrangements.
