This is in reference to the online application received through MHA portal vide online ID No. 2023070512017 dated 11/07/2023 on the subject cited above. In this connection, it is to inform you that the premises was re - inspected by officer concerned of this department on 20/07/2023 in the presence Sh. Yogesh (Manager) to check the shortcomings already issued by this deptt. vide letter No.- F.6/DFS/MS/ EH/WZ/2023/59 dated 03/02/2023.

During the course of inspection, it was observed that the said restaurant is running at Ground Floor in a building comprised of Ground + 03 Upper Floors. Fire safety arrangement of the restaurant such as Fire Extinguishers, MOEFA, First Aid Hose Reel & Down Comer is provided. However, the status of shortcomings is as under.

The licensing issuing authority/statutory authority is requested that premises should not be allowed to run till it provide all necessary fire arrangements.
