This is in reference to the online application received through MHA portal vide online ID No. 2023072112952 dated 21/07/2023, on the subject cited above. In this connection, it is to inform you that the premises was re-inspected by officer concerned of this department on 04/08/2023 in the presence Sh. Ashok Yadav to check the shortcomings already issued by this deptt. vide letter No.- F6/DFS/MS/WZ/EH/2022/682 dated: 29/11/2022.

During inspection, it has been observed that said restaurant/eating house is running at ground floor of TDI Epicuria Mall (J.R. Sood & Company Pvt. Ltd.) in a building comprised of 02 Basement, Ground, 04 Upper floors was issued FSC by his deptt. vide letter no.- F6/DFS/MS/HQ/2020/95 dated 06/09/2020. Fire safety arrangement of the restaurant such as Fire Extinguishers & Smoke Management System is provided. However, the status of shortcomings is as under.

In view of above Shortcomings the application for Issuance of Fire safety Certificate is rejected. The occupancy of the Building/ premises in absence of requisite fire safety arrangements shall be at the risk and liabilities of the Owner/occupier. The licensing issuing authority/statutory authority is requested that premises should not be allowed to run till it provide all necessary fire arrangements.
