Sir,

Please refer to your online application no.:- 2023080313871 dated 09/08/2023 on the subject cited above. In this connection, it is to inform you that the premises was inspected by officers concerned of this department on 18/08/2023 in the presence of Sh. Gagandeep Singh to see the functioning of fire safety equipments provided in the building.

During inspection, it has been observed that the restaurant is running at 1st & 2nd floor in a building comprised of Ground + Mezzanine + 02 Upper floors. Fire safety arrangements such as Fire Extinguishers, First Aid hose reels, Internal Hydrant & Terrace Pump, MOEFA, etc provided. However the following shortcomings were observed.

1. First Aid- Hose reel is provided but not functional.
2. Smoke & Heat Detectors are found removed.
3. MOEFA is provided but not functional.
4. Internal Hydrant is provided but not functional.
5. Main pump capacity of 2280lpm, jockey pump capacity of 180lpm & terrace level pump capacity of 450 lpm is provided but not functional.
6. Standby pump capacity of 2280lpm is found removed.
7. Underground water storage tank capacity of 50,000 ltr is provided on terrace but found empty.
8. Exit signage found removed.

In view of above Shortcomings the application for renewal of Fire Safety Certificate is not considered & rejected. The occupancy of the building/premises in absence of requisites fire safety arrangements shall be at the risk and liabilities of the owner/occupier. The licensing issuing authority/statutory authority is requested that premises should not be allowed to run till it provide all necessary fire arrangements.
