
Please refer to the online application ID No. 2023110618207 dated 06/11/2023, received through MIA portal on the subject cited above. In this connection, it is to inform you that the premises was inspected by the officer concerned of this department on 16/11/2023 in the presence of Sh. Kapil (Shift Manager) to check the fire safety arrangements provided in the building.

During inspection, it was observed that the said restaurant is running at ground floor in a building comprised of Ground + 03 upper floors. The fire safety arrangements such as Fire Extinguishers, First-Aid Reels, etc are provided. However the following shortcomings were observed.

1. Door size 1.5 X 2 mts are provided but found blocked.
2. First-Aid hose reel is not provided.
3. MOEFA is provided but not functional.
4. Internal hydrant is not provided.
5. Main Fire Pump of capacity 450 L.P.M, is not provided.
6. Over Head Water storage tank capacity of 10,000 ltrs is not provided.
7. Exit Signage's are not provided.

In view of above Shortcomings, the application for issuance of Fire safety Certificate is not considered at this stage & rejected. The occupancy of the Building/premises in absence of requisites fire safety arrangements shall be at the risk and liabilities of the Owner/occupier. The licensing issuing authority/statutory authority is requested that premises should not be allowed to run till it provide all necessary fire arrangements.
