Kunal to check the shortcomings already issued by this deptt. vide letter No.- F6/DFS/MS/EH/WZ/2023/114 dated: 07/03/2023.

During inspection, it has been observed that said restaurant is running at 1st Floor in a building comprised of Basement, Stilt, ground + 3 upper floors. Fire safety arrangements of the restaurant such as Fire Extinguishers, MOEFA, First – Aid Hose Reel & Internal Hydrant is provided. However, the status of shortcomings is as under.
