In this connection, it is to inform you that the premises was re inspected by officers concerned of this department on 13/03/2024 in the presence Sh. Narender to check the shortcomings already issued by this deptt. vide letter No.- F6/DFS/MS/WZ/EH/2024/90 dated: 04/03/2024.

During inspection, it has been observed that the above said restaurant is running at upper ground floor in a City Square Mall 02 Basement + Ground + 04 upper floors was issued FSC vide letter no. F6/DFS/MS/WZ/Mall/2023/473 dated 05/10/2023. Fire safety arrangements such as Fire Extinguishers, Smoke Management system, First Aid Hose Reels, Automatic fire detection and alarming system, Internal Hydrants, Pumping Arrangements etc provided.

However, the status of shortcomings is as under.

In view of above Shortcomings the application for renewal of Fire safety Certificate is not considered at this stage & rejected. The occupancy of the Building/premises in absence of requisite fire safety arrangements shall be at the risk and liabilities of the Owner/occupier. The licensing issuing authority/statutory authority is requested that premises should not be allowed to run till it provide all necessary fire arrangements.
