Sub: Regarding renewal of Fire Safety Certificate of "The Ashok Hotel" located at 50-B, Chanakyapuri, New Delhi-110021

Sir,

This has reference to your letter No. AH/Engg/E&M/Inspection/24 dated 10/07/2024 received through outdoor diary No. 4093 dated 11/07/2024. In this connection, inspection from fire & escape safety point of view was conducted by the officers concerned of this department on dated 02/08/2024 in your presence and Sh. Sh. Satish Kumar (Asst. Manager). During the course of inspection, the shortcomings observed are as below.

- 1. Fire Check Door found removed at some places.
- 2. Single exit provided in "The Coffee Shop" against required two exits.
- 3. Hose-reel hose at terrace found removed.
- 4. Electrical shaft not sealed properly at some places.
- 5. MOEFA/MCPs found under repair/replacement.
- 6. Public Address system need to be extended in presidential suites.
- 7. Sprinklers found removed in Friendship Lounge & Banquet Hall.
- 8. Over-head storage tank found removed.
- 9. Exit signages found removed at some places.
- 10. Lift signages found removed at some places.
- 11. Second exit of service lift at 7th floor found closed/sealed.
- 12. Luggage lift was under repair/replacement.
- 13. Ordinary doors provided in lift lobby at 3rd floor shall be replaced with fire/smoke door.
- 14. Loose wires hanging at a height less than 6 feet are dangerous & safety hazards.

In view of the shortcomings above, the application for renewal of fire safety certificate is rejected. The occupancy of the building/premises in the absence of requisite fire safety arrangements shall be at the risk and responsibility of the owner/occupier. The licensing/local authority may take suitable necessary action as deemed fit.

- Loose wires hanging at a height less than 6 feet are dangerous & safety hazards.
