In this connection it is to inform you that the above said premises was visited by the officer concerned of this department on 20/09/2024 in the presence of Mr. Gautam (Caretaker) to see the compliance of the shortcomings communicated vide this office letter No. F6/DFS/MS/SZ/2024/School/480, dated 30/07/2024 and found that the shortcomings are still not complied.

Apart from this it was observed that the stilt floor has been converted in office & children activity area. The stilt floor must be used as per approval of DDA/ MCD.

In view of the above shortcomings renewal of Fire Safety Certificate from fire safety point of view cannot be considered at this stage. You are directed to comply the shortcomings under intimation to this department for further consideration in the matter.

During the course of inspection following shortcomings are observed.

1. Hose reel hose & hydrants found nonfunctional.
2. PA system found nonfunctional.
3. Terrace fire pumps found nonfunctional and not in auto mode.
4. Exit signage's found removed at some places.
5. One room found erected at terrace.

In view of the above shortcomings renewal of Fire Safety Certificate cannot be considered at this stage. You are requested to comply the above mentioned shortcomings under intimation with this department for further consideration in the matter.
